The TTC is committed to an inclusive consultation process to determine a location for a new second exit/entrance to improve customer safety and convenience at Greenwood Station.

The planning process was developed by a panel of outside experts including urban designers, architects, a local construction expert and a transit historian. It involves forming a local working group of community representatives who will put forward and evaluate location options using a framework that was developed by the Expert Panel. Applications are due by Monday, May 15, 2017. The Expert Panel on Second Exits will review all applications and select members. TTC will then notify each applicant. Meetings of the Local Working Group will begin shortly afterwards, and will be open to the community.
